Letter of Commitment

Due to the corona virus pandemic and its effect on the ability of children to attend public school in person, The Salvation Army Boys & Girls Club is offering a Facilitated Learning Center. The center will operate M-F from 9am-5pm to help our parents whose children need supervision and support to focus on their schoolwork. We are committing to provide a safe and engaging space for your child to continue their education in accordance with health guidelines from the governor's office, The CDC, The Boys & Girls Club and of course The Salvation Army. We will provide instructional facilitators, basic health and safety supplies, and lunch for your child (breakfast is not provided).

What we are asking of our parents is to reserve a seat for their child(ren) by paying either weekly or monthly in advance. The fee is \$100 per week per child. If paying for the entire month it will be \$300 a month (that is a \$100 discount). Payment must be received in advance. Please see pay schedule for payment due dates. We understand the need for you to communicate with your child, however we will be monitoring phone usage to keep their focus on schoolwork.

We are also asking that you have your child(ren) here on time each day by 9:00 am. When picking up your child please contact our front desk. Concerning attendance, it is important to notify us if your child will need to miss any time from school. After 4 unexcused absences (no call, no show) you will be notified about your child's enrollment status. By the fifth absence your spot will be filled by someone on the waiting list and you will forfeit any monies paid to the club. If your child is showing flu like symptoms, you will notify the B&GC and will keep your child home.

We look forward to an exciting and successful year with you and your family.

Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Salvation Army, for locally operated Boys & Girls Club programs, has put in place preventative measures to reduce the spread of COVID-19; however, The Salvation Army **cannot guarantee** that you or your child(ren) will not become infected with COVID-19. Further, **attending The Salvation Army Boys & Girls Club program could increase** your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending The Salvation Army and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at The Salvation Army Boys & Girls Club program may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Salvation Army employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at The Salvation Army Boys & Girls Club program or participation in Salvation Army Boys & Girls Club programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless The Salvation Army, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of The Salvation Army, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Salvation Army Boys & Girls Club Program.

If a court rules that this Risk and Waiver of Liability is too broad, the Parties agree to modify it to comply with the law so that the intent of the document is maintained.
